**CONSENT OR RELINQUISHMENT OF MINOR FOR ADOPTION**  
**(Ala. Code §26-10E-11 and 13 (1975))**  
**(LICENSED CHILD PLACING AGENCY)**

KNOW ALL MEN BY THESE PRESENTS, that I, \_\_\_\_\_,

under oath, do hereby state, agree and consent to the following:

(b) consent to the adoption of the said minor only by (list all legal names) \_\_\_\_\_; **or**  
(c) relinquish the said minor for the purpose of adoption to \_\_\_\_\_  
in order that said minor may have all the privileges which may be accorded to the minor by the laws of Alabama upon the legal adoption.
2. I am executing this document voluntarily and unequivocally thereby *consenting to the adoption of* *relinquishing* said minor;
3. I understand that by signing this document and the subsequent court order to ratify the consent, I will forfeit all rights and obligations to said minor and that I understand the *consent to the adoption* *relinquishment* and execute it freely and voluntarily;
4. I understand that the *consent to the adoption* *relinquishment* may be irrevocable, and I should not execute it if I need or desire psychological or legal advice, guidance or counseling;
5. I have received or been offered a copy of this document and the Notice of Withdrawal;
6. I waive the right to know the identity of each petitioner(s) who petition(s) to adopt the said minor child;

7. *I waive further notice of the adoption proceedings by the execution of this relinquishment to the named agency or I waive further notice of the adoption proceedings by the execution of this consent, unless there is a contest or appeal of the adoption proceedings;*
8. I have been advised and understand that notice of withdrawal of *consent relinquishment* must be mailed to and/or filed with the Probate Court of \_\_\_\_\_ County at the following address: \_\_\_\_\_ (*mailing address*) or \_\_\_\_\_ (*physical address*) and a copy to the Petitioner(s)' attorney/Licensed Child Placing Agency/Petitioner(s) \_\_\_\_\_ (*mailing address*) or \_\_\_\_\_ (*physical address*).
9. I have been advised and understand that such withdrawal of *consent to the adoption relinquishment* must be mailed to and/or filed with the Probate Court of \_\_\_\_\_ County, Alabama within five (5) business days after the birth of said minor or the execution of this document whichever comes last.
10. I understand that after the five (5) business days but before the entry of the final judgment of adoption, the express *consent relinquishment* may be withdrawn if the Court determined, it was obtained by fraud, duress, mistake, or undue influence on the part of, or on behalf of the petitioner(s).
11. I understand that the adoption may not be collaterally attacked after entry of the final judgment of adoption, except as authorized by *Ala. Code §26-10E-14 (1975)*. After one year from the date of entry of the final judgment of adoption and after all appeals, if any, an express *consent relinquishment* may not be challenged on any ground except in cases of fraud or cases in which the adoptee has been kidnapped.
12. I do hereby request that the Judge of Probate make all such orders and decrees as may be necessary or proper to legally effectuate said adoption; and
13. I do **or** do not consent to the disclosure of identifying information to said child after he/she reaches the age of 19 years as such information relates to me.
