9. I understand that the consent to adoption may be irrevocable, and I should not execute it if I  
need psychological or legal advice, guidance or counseling.

10. I have received or been offered a copy of this document along with the Notice of Withdrawal.
11. I have been advised and understand that a withdrawal of the express consent to adoption must be mailed to and postmarked and/or filed with the Probate Court of \_\_\_\_\_ County, Alabama within five (5) business days after the execution of the consent at the following address:

12. I understand that after the five (5) business days but before the entry of the final judgment of adoption, the express consent may be withdrawn if the Court determined, it was obtained by fraud, duress, mistake, or undue influence on the part of, or on behalf of the Petitioner(s).
13. I understand that the adoption may not be collaterally attacked after entry of the final judgment of adoption, except as authorized by *Ala. Code* §26-10E-14 (1975). After one year from the date of entry of the final judgment of adoption and after all appeals, if any, an express consent may not be challenged on any ground except in cases of fraud or cases in which the adoptee has been kidnapped.
14. I do hereby request that the Judge of Probate make all such orders and decrees as may be necessary or proper to legally effectuate said adoption.
